 2. An application was filed against M/DION GLOBAL SOLUTIONS LIMITED under Section 9 of Insolvency and Bankruptcy Code, 2016 read with Rule 6 of the Insolvency and Bankruptcy (Application to Adjudicating Authority) Rules, 2016 before the Hon'ble NCLT Delhi with a prayer to commence the Corporate Insolvency Resolution Process (CIRP). The said application for initiation of Corporate Insolvency Resolution Process (CIRP) has been admitted by Hon'ble National Company Law Tribunal (NCLT), New Delhi Bench, (Insolvency NCLT Hon'ble Adjudicating Authority) with an order dated 18.08.2020. Under the IBC proceedings, the power of the Board was suspended with effect from 18.08.2020. The NCLT order also provided for a moratorium with effect from 18.08.2020 till the completion of the Corporate Insolvency Resolution Process (CIRP) or until it approves the resolution plan under section 31(1) or passes an order for liquidation of the company under section 33, whichever is earlier. Currently, the CIRP process in respect of the company is in progress. In terms of Section 20 of Insolvency code, the management and operations of the Company are being managed by Interim Resolution Professional (IRP) (Resolution Professional (RP)).
 3. All the respective decisions of the Company, CFO and Company Secretary have been approved by the Committee of Creditors and CIRP. In the absence of these concerned officials, who are primarily responsible for the book-keeping process and financial reporting, the Resolution Professional has got these financial statements prepared through present employees of the Company and Interim Resolution Professional. These financial statements have been taken on record by the Resolution Professional while monitoring the operations of the Board of Directors of the Company, which have been confirmed upon him in terms of the provisions of Section 17 of the Code. Resolution Professional has taken on record these financial statements in good faith solely for the purpose of compliance with discharging his duty under the Code.
 4. As per regulation 31(2)(b) of the SEBI (ICDR), 2015, if the listed entity has subsidiaries, it shall, while submitting annual audited financial results also submit annual audited consolidated financial results along with the audit report. It is to be noted that Resolution Professional in his powers shall have control over management of the corporate debt only and not on its subsidiary, associate, or any other group companies. Hence only standalone audited financial results are submitted with the stock exchange.
 5. As per Regulation 31(2)(b) of the SEBI (ICDR) Regulations and Disclosure Requirements Regulations, 2015, the Financial Results of a Company submitted to the Stock Exchange shall be signed by the Chairperson or Managing Director or Whole Time Director or in absence of all of them, it shall be signed by any of the Director of the Company who is fully authorized by the Board of Directors to sign the Financial Results. In view of the ongoing Corporate Insolvency Resolution Process commenced on 18th August 2020, powers of the Board of Directors have been suspended and these powers are now vested with the Resolution Professional of the Company, who is authorized to sign the Financial Results on behalf of the Company. Accordingly, the above Financial Results of the Company for the quarter ended 30th June 2024 were taken on record and approved for issue to investors on behalf of the Resolution Professional.
 6. A Resolution Plan received during the Corporate Insolvency Resolution Process has been approved by the Committee of Creditors and the same has been submitted to the Hon'ble NCLT. The matter is still pending with Hon'ble NCLT for final approval.
 7. As the Company is into Software Product and Services Business, license fees/revenue may vary from quarter to quarter.
 8. The Company is primarily engaged in the business of Software Product and Services, which is in the opinion of management is considered to be its reportable business segment as per Ind AS 108 on 'Operating Segment' prescribed under Section 133 of the Companies Act, 2013.
 9. The previous quarterly figures have been regrouped/reclassified wherever necessary to correspond with the current quarterly classification/disclosure.
